### **Final Response ATIPP Access Request 23-562**

The Department of Highways and Public Works has searched the Asset Management Branch and has identified records responsive to Access Request 23-562 noted below:

**I'm looking for information around the department of highways and public works' decision to auction off the diesel engine that sat on the Whitehorse waterfront until 2023. Also looking to find out if it was successfully auctioned, how it was removed from the waterfront, and the price it sold for, as well as what kind of hazardous materials might have been present in the car and why bidders were not allowed to inspect the trolley in advance. Timeframe: November 15, 2021 - December 31, 2023**
