ATIPP Act Sections	Explanation
Section 67(3)(a)	The head of a responsive public body must not grant an applicant access to a Cabinet record.
Section 74(1)(a)	Advice or recommendations prepared by or for a public body or a minister.
Section 76(1)	Disclosure could harm relations between the Government of Yukon and another government or organization.
Section 70(1)	Disclosure of the information would be an unreasonable invasion of the third party's privacy.
