#### **Final Response ATIPP Access Request 22-650**

##### **Decision**

The Department of Highways and Public Works has searched the Capital Development branch and has identified records responsive to Access Request 22-650. The final response on the information is as follows:

##### **Access Granted in Part**

The Department of Highways and Public Works has granted access in part to information relating to the request noted below:

**I would like to see all the pertinent information required to be able to determine the basis for how the final scoring was arrived at for the two bidders for the Dawson Sawmill renovation. This would include bidders responses and the scores for those responses. Timeframe: February 1, 2022 - June 15, 2022**
