The Department of Energy, Mines and Resources has completed its review of the records responsive to Access Request #22-156 and we are pleased to inform you that access is being granted to the enclosed 275 pages of records.

Some of the information has been redacted and withheld from disclosure under subsection 70(1) because disclosure would be an unreasonable invasion of third party privacy and subsection 73(a) of the Act because the information is advice given by a solicitor to a client.
