Decision

Access Granted in Part

The Executive Council Office has granted access in part to information relating to the request noted below:

Disclosure of all internal documents and records, correspondence, records of decisions and documents, including handwritten or other notes, reports or memos under the control of (Canada – Yukon Nature Agreement (the “Agreement”), made December 14, 2022) relating to the Agreement that were created, received or transmitted between December 15, 2021 and December 14, 2022.

An applicant may, in respect of the head of a responsive public body's response to their access request under section 64, make a complaint to the commissioner by filing the complaint in accordance with section 90.


