Re: ATIPP Request 24-181 Final Response – **Access Granted in Full**

Decision

The Yukon Hospital Corporation has identified records responsive to Access Request 24-181. The final response on the information is as follows:

Access Granted in Full

The Yukon Hospital Corporation has granted full access to the information relating to the request noted below:

Primarily I would like to obtain information organized by separate fiscal year and by department, on total expenditures in Whitehorse at hotel establishments and similar organizations. Specifically, any expenditure in Whitehorse that fits into 'Housing, Accommodation, Hotels' contract type, per the Yukon Contracts Registry, or "Professional Services - Others" in relation to accommodations, housing, or hotels, or "Relocation Services." If possible, please exclude contracts and expenditures, which include conference room rentals and catering. Secondly, I would like to have a specific break down for expenditures at the Sternwheeler Hotel, previously known as the Westmark Whitehorse, which was the current Vendor Name 'HL General Partner Inc.' Timeframe: April 1, 2019 - April 1, 2024.

ADDITIONAL INFORMATION:

PB: *The program area has requested clarification on what "similar organizations" may refer to.*

APP: *"Similar organizations" refers to any business, or unincorporated persons conducting business, in the provision of services categorized as:*

- *Housing, Accommodation, Hotels;*
- *Professional Services - Others in relation to accommodations, housing, or hotels; and*
- *Relocation Service*

PB: *"Do they want our total costs for housing from an income statement perspective or do they want a vendor listing by fiscal year of the places we have housed staff. Does that include our internal costs of Crocus Ridge?"*

For Yukon Hospitals Corporation, relocation services are just a reimbursement of moving costs up to our maximum allowance. Do they want to see those costs or more specifically costs related to temporary housing etc.? "

APP: I am seeking total expenditures at all hotel establishments and similar organizations as previously clarified.

That does not include Crocus Ridge.

Then, I am requesting a specific attribution to HL General Partner (The Sternwheeler Hotel).

One report compiled with information from the Finance department.

There will be no charge to the applicant.
