#### Final Response ATIPP Access Request 25-114

The Department of Energy, Mines and Resources has searched and has identified records responsive to Access Request 25-114 noted below:

Any and all documents that show that the Commissioner of Yukon, or the Commissioner in Executive Council, has delegated the discretionary authority to cancel agreements for sale under section 12 of the Lands Regulations (O.I.C. 1983/192) to any other person or office.

Specifically, I am seeking:

Any Orders-in-Council, delegation instruments, or legal instruments—past or present—that delegate this authority to a Minister, Deputy Minister, Assistant Deputy Minister, Director, or any other official within the Yukon public service.

Any associated memos, internal policies, or communications that confirm or rely on such a delegation.

The date and legal basis for any such delegation, if it exists.

For clarity, section 12 of the Lands Regulations states that “The Commissioner may enter and take possession... of any lot” under certain conditions. I wish to confirm whether this decision-making power has been lawfully delegated, and to whom
