### **Decision**

The Department of Environment has searched Finance branch and has identified records responsive to Access Request #22-256. The final response on the information is as follows:

### **Access Granted in Part**

The Department of Environment is granting access in part to information relating to the request noted below:

We are requesting the most recently updated departmental ministerial budget briefing binders for the 2022 Spring Sitting of the Yukon Legislative Assembly, containing the most recent version of ministerial briefing notes. Timeframe: April 18, 2022 - April 29, 2022

Some of the records you requested contain information that has been withheld from disclosure under the ATIPP Act. We have severed the excepted information so that we could disclose to you the remaining information in the records. The records have been withheld pursuant the following sections under the *Access to Information and Protection Privacy Act* (ATIPP Act):

#### **ATIPP Act Sections**

- Section 67(3)(b)

#### **Explanation**

- The head of a responsive public body must not grant an applicant access to information contained in a record other than a Cabinet record that, if disclosed, would reveal the substance of the deliberations of Cabinet


