Hello all,

I am writing to let know that the Yukon Employees' Union (YEU) has informed the Public Service Commission of their intent to begin selecting employee members for vacancies on health and safety committees. **YEU as a trade union** has the legislated right to select members for health and safety committees (see excerpts from the OHS Act below)

Our Collective Agreement with the Yukon Employees' Union does not articulate a specific process for selecting employee members of health and safety committees. For now, YEU is notifying the Public Service Commission of their selections and my office is notifying the committee co-chairs. The YEU may also reach out to Co-Chairs directly, so I am taking this opportunity to remind you of the YEU's right to do so.

The process for **selecting a worker co chair** is also indicated in both present and future legislation. The members of the committee select the co-chairs according to the terms of reference (employee members select the worker co-chair and management members select the management co-chair from within the committee membership). In the event there is more than one nominee, a vote between the members shall take place to decide on the co chair position.

#### **Current language from section 12 part 6 and 7 of the current OHS act:**

(6) A committee shall consist of a minimum of four and a maximum of 12 persons of whom at least half shall be workers who do not exercise managerial functions and shall be selected by the workers they represent **or by the trade union, if any, that represents the workers.**

(7) **Committees shall have two co-chair, one chosen by the employer members, the other chosen by the worker members, and the co-chair shall alternate the function of chairing the meetings of the committee and shall participate fully in the deliberations and decisions of the committee.**

#### **Language after July 1<sup>st</sup> from part 3 section 37 the new WSC Act:**

37(1) A committee must

- (a) have at least four members; and
- (b) include employer representatives and worker representatives.

(2) At least half of the members of a committee must be worker representatives who

- (a) do not exercise managerial functions at the workplace; and
- (b) are selected by
  - (i) the workers, or
  - (ii) the trade union that represents the workers at that workplace.
- (3) The worker representative committee members must appoint a co-chair from among themselves and the employer representative committee members must appoint a co-chair from among themselves.

As you submit your minutes to the Sharepoint site each month, please also notify [safety@yukon.ca](mailto:safety@yukon.ca) of vacancies on any of your committees employee membership or in your co-chair. Corporate Health and Safety is working on a template to track and post your membership that complies with some new requirements in the WSC act that will also need to be uploaded to the sharepoint monthly. More on this in the coming weeks

**Subject:** Yukon Employees Union and Joint Health and Safety Committee membership

Hello all,

I am writing to let know that the Yukon Employees' Union (YEU) has informed the Public Service Commission of their intent to begin selecting employee members for vacancies on health and safety committees. **YEU as a trade union** has the legislated right to select members for health and safety committees (see excerpts from the OHS Act below)

Our Collective Agreement with the Yukon Employees' Union does not articulate a specific process for selecting employee members of health and safety committees. For now, YEU is notifying the Public Service Commission of their selections and my office is notifying the committee co-chairs. The YEU may also reach out to Co-Chairs directly, so I am taking this opportunity to remind you of the YEU's right to do so.



The process for **selecting a worker co chair** is also indicated in both present and future legislation. The members of the committee select the co-chairs according to the terms of reference (employee members select the worker co-chair and management members select the management co-chair from within the committee membership). In the event there is more than one nominee, a vote between the members shall take place to decide on the co chair position.

**Current language from section 12 part 6 and 7 of the current OHS act:**

(6) A committee shall consist of a minimum of four and a maximum of 12 persons of whom at least half shall be workers who do not exercise managerial functions and shall be selected by the workers they represent **or by the trade union, if any, that represents the workers.**

(7) **Committees shall have two co-chair, one chosen by the employer members, the other chosen by the worker members, and the co-chair shall alternate the function of chairing the meetings of the committee and shall participate fully in the deliberations and decisions of the committee.**

**Language after July 1<sup>st</sup> from part 3 section 37 the new WSC Act:**

37(1) A committee must

- (a) have at least four members; and
- (b) include employer representatives and worker representatives.

(2) At least half of the members of a committee must be worker representatives who

- (a) do not exercise managerial functions at the workplace; and
- (b) are selected by
  - (i) the workers, or
  - (ii) **the trade union that represents the workers at that workplace.**

(3) **The worker representative committee members must appoint a co-chair from among themselves and the employer representative committee members must appoint a co-chair from among themselves.**

As you submit your minutes to the Sharepoint site each month, please also notify [safety@yukon.ca](mailto:safety@yukon.ca) of vacancies on any of your committees employee membership or in your co-chair. Corporate Health and Safety is working on a template to track and post your membership that complies with some new requirements in the WSC act that will also need to be uploaded to the sharepoint monthly. More on this in the coming weeks

Hello Co chairs

Recently the Yukon Employees Union (YEU) has been conducting investigations into YG Joint Health and Safety Committee (JHSC) functions and structure and is now exercising their legislated rights to select committee members from their membership as outlined in email from me earlier this week. (Also attached for reference) Keep in mind that member selection can happen in this manner, but if there are more candidates than positions, a vote must take place. Also the union cannot appoint or nominate a co chair from the worker members.

They have also expressed a desire to attend the monthly committee meetings. This is not an appropriate forum for the YEU as there are a number of other avenues to communicate to their membership and the employer as outlined below. We have communicated this to the union directly and would now like to give you some guidance regarding if and when you receive a request to attend your meetings from the union.

If you receive such a request respond and thank them for their interest in their memberships health and safety and inform them that YG does not view their attendance at committee meetings appropriate, or necessary, and remind them that there are a number of opportunities for YEU to engage with the employer on health and safety matters and to advocate for union members' health and safety interests. These include:

- selecting worker representatives to participate on workplace Joint Health and Safety Committees
- reviewing the health and safety committee minutes which the employer regularly provides to YEU and communicating with your members who on those committees about concerns or observations you form based on the minutes
- attending and participating as a member in the Health and Safety Leadership Committee (HSLC)
- bringing forward to Joint Consultation any safety matters related to an application of the Collective Agreement
- attending informal check-ins with the Director, Health, Safety and Wellbeing at the Public Service Commission to engage in proactive discussions about health and safety initiatives, incidents and programs
