# Final Response ATIPP Access Request 23-580

The Department of Economic Development has searched Regional Economic Development branch and has identified records responsive to Access Request 23-580 noted below:

70(1)	Disclosure of third party names would be an unreasonable invasion of third party privacy
75(1)(a)(ii)	Disclosure of the public body's monetary risk evaluation criteria would harm the public body's economic interests
77(1)(a)	Disclosure of third party commercial and financial information could result in undue financial loss to a third party and undue financial gain to any other third parties
