Decision

Access Granted in Part

The Department of Highways and Public Works has granted access in part to the information relating to the request noted below:

Looking for detailed information on the fuel pricing for Gasoline, diesel, home heat that YTG has paid for 2022. there is a spreadsheet that tracks pricing updates that i have received in the past that works. Timeframe: January 1, 2022 - December 31, 2022

ADDITIONAL INFORMATION:

Question #1: Do you want us to provide the total amount of money spent on fuel or the price per litre for each type of fuel?

Response #1: Just price per litre is fine.

Question #2: The applicant was also asked if they would be able provide us with the spreadsheet they had received in the past, just as a potential helpful reference point or if they were able to indicate which part of Highways and Public Works they obtained this spreadsheet from.

Response #2: I cannot locate the spreadsheet. The department of highways maintains a spreadsheet that tracks all of the different pricing updates by week, by month. That's the best I can do. That is really all I am looking for.


An applicant may, in respect of the head of a responsive public body's response to their access request under section 64, make a complaint to the commissioner by filing the complaint in accordance with section 90.
