Final Response ATIPP Access Request #23-574

Decision

The Department of Finance has identified records responsive to Access Request #23-574. The final response is as follows:

Access Granted in Part

The Department of Finance has granted access, in part, to records relating to the access request noted below:

North Klondike Highway Corridor Strategic Upgrades – Phase 2 Mentions of a permanent bridge crossing the Yukon River in Dawson City Discussions involving federal funding of a permanent bridge in Dawson City Discussions involving using the federal funding originally intended to build a permanent bridge in Dawson City to rebuild the Nisutlin Bay Bridge Discussions with the Government of Canada involving a permanent bridge in Dawson City Discussions with the Government of Canada involving the Nisutlin Bay Bridge Discussions with the Government of Canada regarding changing the publicly available information from saying that funding would build a bridge in Dawson City to saying that the funding would help replace the Nisutlin Bay Bridge. At some point, the Government of Yukon requested funding from the Government of Canada for the North Klondike Highway Corridor Strategic Upgrades – Phase 2. And at some point before that funding was approved and announced, a

decision was made to not mention a permanent bridge in Dawson City, since there is no public mention of such a bridge.

Timeframe: January 1, 2020 to February 15, 2024

Question from Dept: The department requires you to clarify what information you are seeking so we can best assist you with this request. Can you please specify what information or records you are requesting from the department of Finance?

Response from App: I'm looking for records involving the funding required to build a bridge in Dawson City including cost analysis and recommendations from the department on how best to use that funding.

I'm also looking for similar records regarding the Nisutlin Bay Bridge, and any indication that funding originally intended for the Dawson bridge be reallocated to Nisutlin Bay.
