Final Response ATIPP Access Request 24-183

The Yukon Housing Corporation has searched Finance branch and has identified records responsive to Access Request 24-183 noted below:

Primarily I would like to obtain information organized by separate fiscal year and by department, on total expenditures in Whitehorse at hotel establishments and similar organizations. Specifically, any expenditure in Whitehorse that fits into 'Housing, Accommodation, Hotels' contract type, per the Yukon Contracts Registry, or "Professional Services - Others" in relation to accommodations, housing, or hotels, or "Relocation Services." If possible, please exclude contracts and expenditures which include conference room rentals and catering. Secondly, I would like to have a specific break down for expenditures at the Sternwheeler Hotel, previously known as the Westmark Whitehorse, which was the current Vendor Name 'HL General Partner Inc.' Timeframe: April 1, 2019 - April 1, 2024.

ADDITIONAL INFORMATION:

PB: Are looking specifically at expenses incurred in the period requested? Are you looking for contracts only?

APPLICANT: I am looking for expenses incurred in the period requested, sorted by fiscal:

- April 1, 2019 – March 31, 2020
- April 1, 2020 – March 31, 2021
- April 1, 2021 – March 31, 2022
- April 1, 2022 – March 31, 2023
- April 1, 2023 – March 31, 2024

Sum of all expenses, not individual contracts.
