Decision

The Department of Environment has searched Parks Branch and has identified records responsive to Access Request 23-096. The final response on the information is as follows:

Additional Information: I am looking for the one to do with enforcement and more specifically what policies and procedures are in place when issuing tickets to campers.**


An applicant may, in respect of the head of a responsive public body's response to their access request under section 64, make a complaint to the commissioner by filing the complaint in accordance with section 90.
