Sorry for the delay in getting back to you. The data you provided from WCC was linked with vaccination records from Panorama, using only name and date of birth as identifiers for linkage. In total, there were 105 names provided.

Of the 105 staff names provided, 82 also had vaccination records in Panorama. 1 (1%) had only received their first dose, while 81 (77%) had received two doses.

Hi Benton,

I hope this email finds you well; it's been a while since we last connected.

When WCC received its first COVID case, we had asked YCDC to provide us with information on our staff COVID vaccination numbers. We weren't looking for names but rather an idea percentage-wise of how many staff at WCC were fully vaccinated. I remember that YCDC asked WCC to provide them with the list of staff names, which was completed in the Summer, but WCC never received the stats from YCDC.

Given the conversations around the country regarding correctional institutions and staff vaccine mandates, the Corrections Branch needs to have a better understanding of potential operational impacts WCC could face if we have to plan for changes to our daily operations. WCC has been successful thus far in managing operations throughout COVID because we planned proactively and we would like to be able to do some proactive planning for this particular scenario.

Can YCDC please provide us with information on our current employee (WCC only) vaccination numbers? Please let Robert know if you need any additional information from us to pull the data we need.

I've copied Jeff Simons on this email because Friday is my last day as Director of Corrections and Jeff will be the A/Director until other arrangements are made.
