**Decision**

The Department of Health and Social Services has searched Community Health Programs and has no records responsive to Access Request 21-413. The final response on the information is as follows:

**No Records Found**

The Department of Health and Social Services has no records responsive to this request:

*As a resident of Yukon and to obtain informed consent for vaccination according to Canadian legislation, I request copies of all documents confirming the isolation of the SARS-COV2 virus with all its variants thereto, in possession of the Health and Social Services of the Yukon Territory. I specifically want certified copies of all documents proving the existence of the ISOLATED SARS-COV2 virus, its variants, and the name and address of the Canadian Virology Center or any other organization that performed the isolation protocol. THIS IS NOT A REQUEST for information for any laboratory setting or Covid PCR test results. I specifically request the Deputy Chief Medical Officer of Health, Dr. Catherine Elliot, and scientific, material, and documentary proof of the isolated SARS-COV2 virus's existence with its variants thereto. This Yukon Government Agency has extensively publicized SARS-COV2 existence. Thus there should not be any concerns to fulfill this request. Please let me know if there are any costs attached with this request and send me the invoice.*

Timeframe: January 1, 2020 - November 16, 2021

Pursuant to section 66 of the Access to Information and Protection of Privacy Act you may contact Yukon's Information and Privacy Commissioner with a complaint in respect to this response. Section 66 states:

*An applicant may, in respect of the head of a responsive public body's response to their access request under section 64, make a complaint to the commissioner by filing the complaint in accordance with section 90.*
