Decision

The Department of Environment has searched Deputy Minister's Office and Fish and Wildlife branch and has identified records responsive to Access Request #22-299. The final response on the information is as follows:

Access Granted in Part

The Department of Environment is granting access in part to information relating to the request noted below:

Bruce.Bennett@yukon.ca. What was the budget for the Yukon's Bioblitz 2018 at Tombstone June 28, 2018 to July 1, 2018? What was the total cost of this Bioblitz? Who was paid on this Bioblitz and how much? How many helicopter trips per day were done? What helicopters were used for this Bioblitz? Timeframe: June 28, 2018 - July 1, 2018.

Some of the records you requested contain information that has been withheld from disclosure under the ATIPP Act. We have severed the excepted information so that we could disclose to you the remaining information in the records.

The records have been withheld pursuant to the following sections under the Access to Information and Protection Privacy Act (ATIPP Act):

<ul style="list-style-type: none">• Section 75(b)(i)	Disclosure may prejudice the financial or economic interests of the Government of Yukon or a public body
