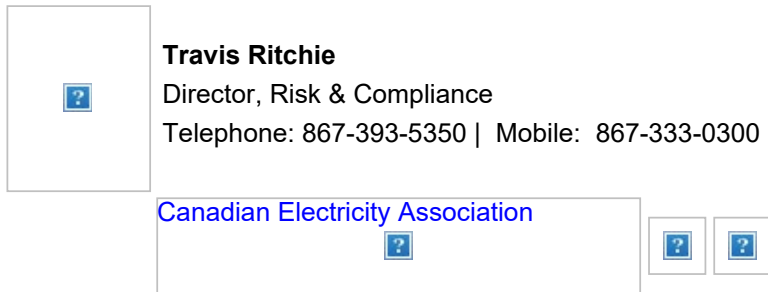

Had a look at the report. It's a good report. No concerns. My only comment would be to ask if it would be reasonable and appropriate for the authors to discuss what they already knows about the mitigation for turbine mortalities, i.e., the Hatchery, and the appropriateness/suitability of the production numbers we maintain there as mitigation for the estimated mortalities identified in the entrainment study. It may be that we are more than offsetting the mortalities or it may be that we are not, but that is the question that comes immediately to my mind and this information will be necessary for the 76(1) and 76(1)
