Decision

Access Granted in Full

The Department of Tourism and Culture – Yukon Archives has granted access in full to information relating to the request noted below:

I want to know what the Fire Marshall's office determination of the S.S. Tutshi fire cause was. Timeframe: July 1, 1990 to end of year 2000.
