Please note, we consider "unsafe sleep deaths" to include a number of circumstances, most often where the cause of death recorded is asphyxiation or suffocation. But it is sometimes recorded as or has sometimes been recorded as Sudden Infant Death Syndrome or Sudden Unexpected Infant Death Syndrome. For that reason, the circumstances of the death may be needed in order to determine whether the record is relevant to the request. Unsafe sleep situations can include but are not limited to instances of co-sleeping (infant and adult or older child in same bed), inappropriate sleep surfaces (soft beds, water beds, armchairs, sofas, pillows etc), items in cribs (loose blankets, bumper pads, stuffed toys, etc).
