ELECTION SUMMARY

A writ of election dated April 12, 1985, was issued by the Commissioner of Yukon pursuant to Section 15 of the Elections Act to each of the 16 Returning Officers.

Nomination Day was Monday, April 22, 1985. A total of 44 candidates were nominated to contest the election. The distribution of nominated candidates by political parties registered under the Elections Act or by political affiliation is as follows:

- Yukon Liberal Party	8
- Yukon New Democratic Party	16
- Yukon Territorial Progressive Conservative Party	16
- Independents	4

No candidates withdrew their nominations and no candidates were elected by acclamation.

Polling Day was Monday, May 13, 1985. There were 13,530 electors entitled to vote of which 10,607 cast ballots.

Advance Polls were held in the 16 electoral districts on Sunday, May 5 and Monday, May 6, 1985. A total of 495 ballots were cast at the 20 Advance Polls established throughout Yukon.

There were 178 electors absent from Yukon on polling day who cast ballots through the appointment of proxy voters.

Mail-in ballots were provided, pursuant to Section 55.3 of the Elections Act, to 4 electors in the Whitehorse General Hospital and 2 electors in the Whitehorse Correctional Institute. The total number of mail-in ballots cast by electors in those two institutions was 5.

Extraordinary measures were ordered by the Chief Electoral Officer, pursuant to subsection 5(2) of the Elections Act, on two occasions where it was determined that significant numbers of electors would not have

access to polling places during the advance and regular polls. In polling division 3 in the Electoral District of Klondike there were 36 electors who, due to spring breakup, did not have access by river or road to the polling place in Dawson City. In polling division 1 in the Electoral District of Old Crow there were 25 electors who flew to the Old Crow Flats on April 28 in order to pursue their annual tradition of trapping muskrats. Since they remained on the Flats until after May 13 they were not able to attend either the advance or regular polls. An extension of the advance poll was ordered in both cases and each returning officer arranged for an aircraft to take a deputy returning officer and poll clerk with a ballot box to the locations where the affected electors were situated. The number of electors who cast their ballots by this method were 31 in the Electoral District of Klondike and 25 in the Electoral District of Old Crow.

On May 10, 1985, the Chief Electoral Officer was ordered, by decision of Maddison, J. of the Supreme Court of the Yukon Territory to add the name of Arnold David Hedstrom to the list of electors for the Electoral District of Whitehorse South Centre. Mr. Hedstrom had successfully petitioned the Court on the basis that the one year residency requirement for electors as found in paragraph 18(1)(c) of the Elections Act was in violation of his right to vote as guaranteed by Section 3 of the Canadian Charter of Rights and Freedoms. In addition, Maddison, J. found that paragraph 18(1)(c) is of no force and effect. This finding did not result in any other person who had been resident in Yukon for less than a year being granted the right to vote because the decision was handed down after the conclusion of revision hearings. It was, therefore, not possible for anyone to have his name placed on the list of electors and, since there is no provision for swearing-in at the polls, there was no legal authority by which such a person could have been issued a ballot paper.

Judicial recounts were required, pursuant to subsection 61(b) of the Elections Act, for the Electoral Districts of Old Crow and Watson Lake because, in each case, the difference between the winning candidate and the candidate with the second highest number of votes was less than

ten. The judicial recounts were both held on May 23, 1985. There was no change in the results for the Electoral District of Old Crow. The only amendment to the results for the Electoral District of Watson Lake was that one vote which had been cast for the candidate with the fourth highest number of votes was rejected.

The returns to the writs of election for the Electoral District of Old Crow and Watson Lake were made on May 23, 1985, immediately following the judicial recounts. The Returning Officers for the Electoral Districts of Hootalinqua and Campbell made returns to the writs of election on May 28, 1985, and returning officers for the remaining 12 electoral districts made returns to the writs of election on May 27, 1985.

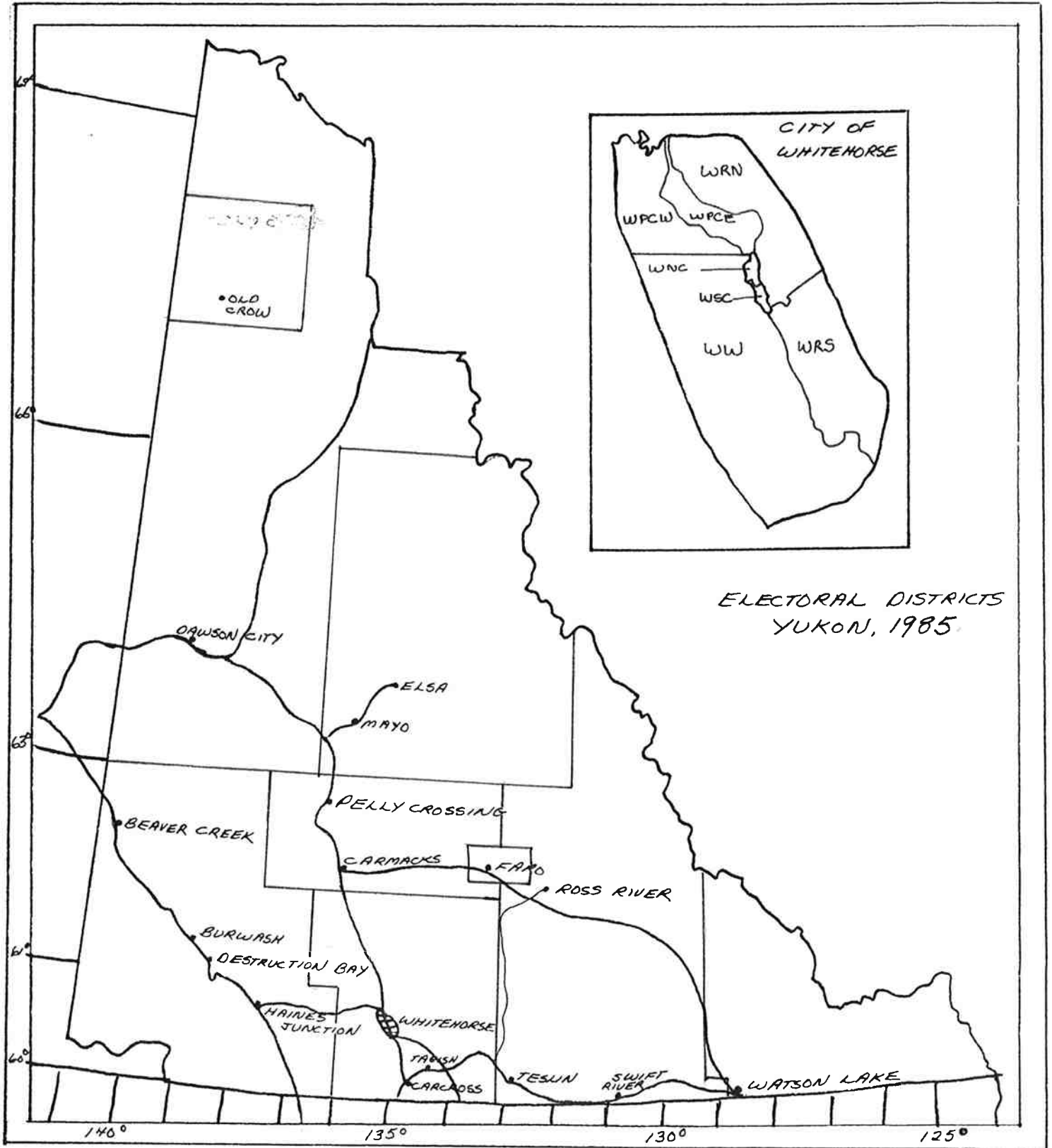
