ELECTION SUMMARY

A by-election was made necessary in the Electoral District of Lake Laberge on the resignation of Doug Livingston (ND) August 30, 1999.

The by-election date was announced on September 3, 1999, by the Government Leader, Piers McDonald. The writ of election was issued on September 24, 1999.

Enumeration was required as the last enumeration in this electoral district took place for the 1996 general election which was more than one year ago. It commenced on the date of the issue of the writ. There were 1,346 electors enumerated. Following revision and special revision, 1,406 electors were eligible to vote.

Nomination day was Monday, October 4, 1999, and three candidates filed nomination papers.


Polling day was Monday, October 25, 1999. There were 1,009 voters at this election. This number included 59 electors who voted at the advance poll held on October 17 and 18, 1999. A recount was not required at this election.


Each candidate was entitled to receive a refund of the nomination deposit. The *Elections Act* requires that the deposit be returned if a candidate receives 25% of the votes cast for the candidate who receives the greatest number.


The returning officer declared Pam Buckway (L) elected on November 8, 1999.


MAPS OF LAKE LABERGE
