## **Government of Yukon announces proposed framework for legalized cannabis**

The Government of Yukon has released its proposed framework for the legalization of cannabis, which will form the basis of new territorial legislation to regulate cannabis in Yukon.

The framework proposes direct control of cannabis distribution and consumption so that the legalization and enforcement associated with the act can be carefully managed.

The management of distribution and consumption will evolve as the government is able to learn more about the best approach for Yukon.

We are particularly concerned about cannabis use by young people. For that reason, we are proposing that Yukoners under the age of 19 will not be allowed to purchase or possess any cannabis."

### **Quick facts**

- The proposed minimum age for the legal possession, consumption and cultivation of cannabis for Yukon residents is 19.
- Adults 19 and older would be allowed to possess up to 30 grams of dried cannabis, or its equivalent, in public, and grow up to four plants per household for personal use.
- The Government of Yukon will own and operate at least one retail store and provide an e-commerce option.
- The new act would allow for private retail through a controlled licensing regime.
