

YUKON LIQUOR CORPORATION BOARD OF DIRECTORS BYLAW 2025-010

Rules Respecting General Matters

preamble

WHEREAS the Yukon Liquor Corporation Board of Directors has determined that it is necessary, desirable and in the public interest that rules be enacted for rules respecting general matters under the *Act* and the *Liquor Regulations*.

THEREFORE the majority of a quorum of the Yukon Liquor Corporation Board of Directors present at a meeting of the Yukon Liquor Corporation Board of Directors duly convened enacts this bylaw to provide for rules respecting general matters under the *Act* and the *Liquor Regulations*.

citation and application

1. This Bylaw: **(1)** is enacted for the purpose of providing rules respecting general matters under the *Act* and the *Liquor Regulations*; **(2)** may be cited as the *General Matters Rules*; **(3)** applies to all to general matters under the *Act* and the *Liquor Regulations*; and, **(4)** must be read with the *Definitions Bylaw*.

licence validity

2. A Licence is valid for the Licensee and the Licensed Premises stated therein only as long as the Licensee continues to be the true owner or lessee of the business carried on at the Licensed Premises.¹

licence expiration

3. A Licence, unless otherwise specified, expires on March 31 in the Licence Year following the Licence Year in which the Licence was issued;² or, if a Licensee is not in good standing at any time during the validity of the Licence, it expires on March 31 immediately following the day on which the Licensee was determined not to be in good standing;³ and, a Licensee is not in good standing if: **(1)** the Licence is suspended;⁴ **(2)** the Licensee is convicted of an offence under the *Act*;⁵ or, **(3)** the

Licensee does not meet the standards established by the Board.⁶
new year's eve

4. On New Year's Eve, any Licensed Premises may remain open for the purposes stated on the Licence from nine o'clock of the afternoon of December 31 until three o'clock in the forenoon of January 1.⁷

board may direct president

5. The Board may direct the President to endorse such conditions on a Licence as the Board may see fit.⁸

fit person

6. No person named shall be endorsed on or continued on the Licence unless they are a fit person in the opinion of the President to manage and operate the premises in respect of which the Licence is issued.⁹

limitation of equipment used

7. The Board may limit the type of equipment used in any Licensed Premises for the purposes of entertainment and may direct a Licensee to remove any such equipment.¹⁰

permit subject to conditions

8. Every Permit shall be for a period and subject to any conditions that may be imposed by the Board.¹¹

licensee to maintain licensed premises

9. Unless the Board otherwise directs, a Licensee shall: **(1)** maintain the Licensed Premises and the fixtures and equipment therein as required by the Board;¹² **(2)** keep the Licensed Premises, including the grounds thereof, clean, tidy and in good repair at all times;¹³ **(3)** have one or more supervisors on duty in the Licensed

Premises when they are required, as the Board directs;¹⁴ (4) maintain in the Licensed Premises an intensity of light that is satisfactory to the Board;¹⁵ and, (5) when a Licensed Premises closes prior to the expiration date of the Licence, return the Licence to the Board.¹⁶

notice to president

10. Any corporation or partnership that is a Licensee shall notify the President of any sale, assignment, or transfer of shares in the corporation or partnership, and if the purchaser, transferee, or assignee is another corporation or partnership, shall provide particulars of the names and share-holdings of the directors and members of that other corporation or partnership.¹⁷; and, any transfer, sale, or assignment of shares in the corporation or partnership which substantially changes the beneficial ownership or control of the corporation or partnership shall invalidate the Licence unless the prior approval of the Board to the change has been obtained.¹⁸

amount of liquor

11. The amount of Liquor shall be as follows: (1) each drink containing Spirits served shall contain not less than one fluid ounce of Spirits by imperial measure or 28.41 milliliters by metric measure, of Spirits;¹⁹ every Licensee shall measure all Spirits served in a drink by means of (i) a clearly marked glass or container of a type approved by the Board or (ii) a mechanical measure of a type approved by the Board;²⁰ and, (3) any liquor that is served by a Licensee shall be served in a container that complies with the requirements, if any, imposed by the Board in the Licensee's Licence.²¹
