This report is published pursuant to section 315 of the *Elections Act, S.Y., 1999, Chapter 13.* 



# **ELECTION SUMMARY**

A by-election in the Electoral District of Faro was caused by the resignation of Trevor Harding on October 22, 2000. The Commissioner of the Yukon ordered the chief electoral officer to issue a writ on October 27, 2000 for an election to take place on Monday, November 27, 2000.

The *Elections Act* states that if a by-election is necessary within one year of the date of the issue of the writ for an electoral district at a general election, the list of electors prepared for that election will be the preliminary list of electors for the by-election. There was no enumeration for this election as the by-election was called within one year of the issue of the writ for the general election on March 17, 2000. Information for electors was delivered to each residence at the beginning of the election period.

Two candidates filed nomination papers before 2:00 p.m. on November 7, 2000, nomination day.


At revision on November 14 and 15, 2000, 22 names were added to the list and 39 names were removed. Three more names were added to the list at special revision on November 24, three days before polling day.

There were 234 eligible electors on the official list for this by-election.

Thirty-seven people voted during the advance poll on November 19 and 20.

On polling day, 160 people voted.
