Government of Yukon appoints Territorial Court judge

WHITEHORSE—The Yukon government announced today the appointment of Peter Chisholm as a judge of the Territorial Court of Yukon.

"After a very thorough process, we are pleased to appoint Judge Chisholm," Justice Minister Mike Nixon said. "Mr. Chisholm has extensive experience with the Public Prosecution Service of Canada and as defence counsel, along with a strong knowledge of the legal system in Yukon. He also has a history of volunteerism in the territory."

Judge Chisholm graduated from Dalhousie University Law School in 1989 and spent a year in private practice in Whitehorse before joining the Department of Justice Canada in 1993. From 1996 to 1998, he was a partner in a Whitehorse law firm and then spent a further two years working for the Yukon Legal Services Society.

In 2000, he rejoined the federal Department of Justice, which became the Public Prosecution Service of Canada, working both in Yukon and in Atlantic Canada until his appointment as judge of the Territorial Court of Yukon.

Mr. Chisholm was the successful candidate in a selection process set out in the Territorial Court Act which requires the Judicial Council to seek potential candidates, conduct interviews and submit recommendations to the Minister of Justice. The Judicial Council is made up of representatives of the Yukon Supreme Court, the Territorial Court of Yukon, Yukon First Nations, the Law Society of Yukon and lay people.
