Final Response ATIPP Access Request 21-219

Decision

The Executive Council Office searched the Premier's Office, Deputy Minister's Office, Strategic Corporate Services branch, Aboriginal Relations branch, Intergovernmental Relations branch and the Policy and Communications branch and identified records responsive to Access Request #21-219. Our final response on the information is as follows:

Access Granted in Part

The Executive Council Office has provided partial access to information and records relating to the request noted below:

Emails, memoranda, decks, or any other documents regarding the decision to reduce COVID-19 restrictions effective August 4, 2021. Please omit duplicate emails. Given the public interest in this matter I request that the department not use discretionary exceptions to disclosure. Timeframe: 01 June 2021 - 29 July 2021

Cabinet information as defined under the ATIPP Act section 67(1)(a), (c), (e), (f) and (g); consisting of advice, recommendations, briefing material prepared for Cabinet, information reflects communications between Ministers in respect to making a government decision, or to brief a minister on a matter to be brought before Cabinet, a record created for the purpose of submission to Cabinet, or, part of a record containing information referred to in (a), (c), (e), (f) and (g) was withheld under section 67(3)(a) of the ATIPP Act as a cabinet record must not be disclosed.

Third party names of individuals and email addresses have been withheld under section 70(1) of the ATIPP Act as disclosure would be an unreasonable invasion of third party privacy.

Information subject to legal privilege of the department of Justice has been withheld under section 73(a) of the ATIPP Act.

Advice and recommendations prepared by a public body for a minister has been withheld under section 74(1)(a) of the ATIPP Act as disclosure would reveal the advice or recommendations.

Information related to other governments or organizations has been withheld under section 76(1) as the disclosure could reasonably be expected to harm relations between a public body and a First Nation government, a municipality, an organization representing one or more governments, or, the Government of Canada.

There is no charge to the applicant.
