Final Response ATIPP Access Request 21-292

**Decision**

The department of Justice has searched the statutory body the Yukon Police Council which is a program or activity of the department of Justice and has identified records responsive to Access Request #21-292. Our final response on the information is as follows:

**Access Granted in Part**

The department of Justice has provided access in part to information and records relating to the request noted below:

Hello, I am looking for any information pertaining to the safe consumption site that has been slated for 6th avenue. I'm looking for anything involving public consultations (planning for them, results, attendance, advertising), any internal emails that were exchanged on the subject, any policy or briefing notes, any objections or concerns that were raised by anyone, any proponents for the project, Anything involving the city of Whitehorse (I want to know what consultation has been done with them regarding local residences, infrastructure (the park, streetlights, crime, etc.), any correspondences with the RCMP or its administrators on the topic, any inquiries about the location, or discussion on where to put the site. This is a broad search. As a suggestion, keywords might include "supervised consumption" "safe consumption" "supervised injection" "safe injection" "SCS" "consumption site" "injection site" "6189 6th Avenue" "harm reduction". I look forward to working with your officers to get this information. Timeframe: 01 January 2021 - 10 August 2021

Third party personal information including information about physical health history and employment history has been withheld using section 70(1) of the ATIPP Act to protect personal privacy.

Section 72(1)(b)(iii) of the ATIPP Act was used to withhold information the disclosure of which could reduce the effectiveness of law enforcement investigative techniques or procedures.

Information has been withheld under section 74(1)(a) of the ATIPP Act as the disclosure would reveal advice and recommendations prepared by and for a public body.

Information related to other governments or organizations has been withheld under section 76(1) of the ATIPP Act as the disclosure could reasonably be expected to harm relations between a public body and a municipality, or the Government of Canada.
