## **Decision**

The Department of Health and Social Services has searched Population and Public Health Evidence and Evaluation and has identified records responsive to Access Request 21-416. The final response on the information is as follows:

### **Access Granted in Part**

The Department of Health and Social Services has granted access in part to the information relating to the request noted below:

Number of positive COVID-19 cases recorded among both students and teachers in Yukon schools since the beginning of the 2021-22 school year. Breakdown of positive cases of both students and teachers by school since the beginning of the 2021-22 school year.

Timeframe: September 1, 2021 - November 17, 2021

#### ADDITIONAL INFORMATION:

The Department would like to clarify if you would like the number of positive COVID-19 cases that are students or teachers in Yukon, or would you like the number of positive COVID-19 that are students or teachers that acquired the infection at school / work?

Response: I'm looking for all of the following:

- 1. The number of students who have contracted COVID-19 since the beginning of the school year;
- 2. The number of teachers who have contracted COVID-19 since the beginning of the school year;
- 3. The number of each broken down by school;

Certain types of information have been redacted pursuant to the following sections of the Access to Information and Protection of Privacy Act:

• 70(1) Disclosure would be an unreasonable invasion of a third party's privacy
