Final Response ATIPP Access Request 21-466

Decision

The Department of Justice has searched the Public Safety and Investigations branch and has identified records responsive to Access Request #21-466. Our final response on the information is as follows:

Access Granted in Part

The Department of Justice has provided records in part relating to the request noted below:

I would like to request copies of all inspection reports and inspection schedules relating to bars and restaurants in the Yukon. Any correspondence naming specific bars as well. Context and comments can be redacted. Specifically want to know what bars have been inspected, and when they were inspected. Would also like a list of all locations that have not been inspected during the time outlined. Timeframe: November 13, 2021 - December 9, 2021

ADDITIONAL INFORMATION:

I am specifically looking for CEMA related inspections for compliance with the rules and regulations imposed on bars and restaurants under CEMA. I want to know how many have been completed by establishment as well as when they were completed.

Information has been withheld under the following sections of the Access to Information and Protection of Privacy (ATIPP) Act:

- 70(1), 70(3)(a)(iii), 70(5)(d)(ii)
 - Information was withheld as disclosure would be an unreasonable invasion of the third party's privacy;
 - Information was withheld as disclosure would reveal third party's employment history;

- Information was withheld as disclosure would unfairly damage the reputation of any person referred to in a record containing the personal information;
- 72(1)(a)(iii), 72(1)(b)(iv)
 - Information was withheld as disclosure would reveal the identity of a confidential source, or information that the source is providing or has provided, to a public body in respect of a law enforcement matter;
 - Information was withheld as disclosure would harm the reputation of a person or organization referred to in a report prepared for the purpose of a law enforcement matter;
- 74(1)(a)
 - Information was withheld as disclosure would reveal advice or recommendations prepared by or for a public body;
