The Department of Economic Development has completed its review of ATIPP Request 22-003 after conducting a thorough search of the program areas for records responsive to this request and determined that the applicant's request will be granted in part related to the following request:

Information requested: I am requesting copies/records from all the departments and corporations listed with this application. The request is for the most recent, final versions at the end of the legislative session of individual ministerial briefing binders or briefing notes prepared for government ministers during the 2021 Fall Legislative Sitting.  
Timeline 2021-10-28 to 2021-12-03

The response totals 215 pages with 124 pages of records granted in full, 77 pages granted in part and 14 pages being outside the scope of the request.

Information pertaining to these pages have been partially severed in accordance with the ATIPP Act under the following sections:

Information in Cabinet records has been withheld under section 67(3)(a) as access must not be granted to Cabinet records as defined in section 67(1)(a), (c) and (f).

Sections 68(1)(a)(b)(ii)(d) – Confidential information from another government. Records obtained in confidence from the Government of Canada, foreign states and a municipality.

Section 73(a) – Information subject to legal privilege of a public body.

Section 74(1)(a) – Policy advice or recommendations records contain advice or recommendations prepared by or for a public body or a minister.



Sections 75(1)(a)(ii)(iv)(b)(i)(ii) – Disclosure harmful to economic or financial interests of the public body. These records contain information that may prove harmful to contractual or third party economic or financial information of third parties and the government as a whole.

Sections 77(1)(a)(c) – Disclosure harmful to third party business interests. Records contain information regarding business dealings of third parties that may cause undue financial hardship or harm the competitive or negotiating position of a third party.

There is no cost to the applicant.
