### Final Response Access Request 22-060

### Decision

The Yukon Workers' Compensation Health and Safety Board has searched the program areas Occupational Health and Safety and Information Management and has identified records responsive to Access Request 22-060. The final response on the information is as follows:

## Access Granted in Part

The Yukon Workers' Compensation Health and Safety Board has granted access in part to the information relating to the request noted below:

All prohibited reprisal complaints filed under s.18 of the Occupational Health and Safety Act. Information to include any correspondence sent to the complainant worker by YWCHSB. Timeframe: April 1, 2021 - February 7, 2022

YWCHSB received three prohibited reprisal complaints during the time period. The investigations in two of those complaints are currently ongoing, and all related records have been withheld in accordance with section 72(1)(b)(i) since their release could reasonably be expected to interfere with law enforcement matters.

In addition, one recorded interview was withheld in its entirety in accordance with section 72(1)(b)(ii) as it could reasonably be expected that release of that information would reduce the effectiveness of the investigation technique used. All Records were de-duplicated using Adobe Acrobat Pro.

There will be no charges to the applicant.
