Decision

The Department of Environment has searched Policy and Planning branch and Deputy Minister's Office and has identified records responsive to Access Request #22-141. The final response on the information is as follows:

Access Granted in Part

The Department of Environment is granting access in part to information relating to the request noted below:

I want all correspondence regarding Yukon government's review of outfitters' guidelines. As well, I am looking for all emails concerning changes to the quota system, specifically changing from multi-year quotas to single-year quotas. I am also hoping for all email correspondence from outfitters and the Yukon Outfitters Association to the Department of Environment regarding potential changes to the quota system. Timeframe: January 3, 2022 - April 8, 2022

Additional Information:

Hoping to narrow this request down.

Here are what I'm hoping for:

- 1) Please exclude any and all legislation.
- 2) Exclude stuff from communications and public engagement.
- 3) Exclude materials from the Fish Wildlife Branch.
- 4) Reduce the timeframe from four to three months.

5) I would like to keep correspondence that is included in the Deputy Minister's office. However, I only want access to emails. The rest -- powerpoints, reports and spreadsheets -- can be removed.

Question: When the applicant is asking to reduce the timeframe from four months to three months, which months would they like to be included? For example, would they prefer February to April or January to March?

Let's go from February to April, please.

Some of the records you requested contain information that has been withheld from disclosure under the ATIPP Act. We have severed the excepted information so that we could disclose to you the remaining information in the records. The records has been withheld pursuant the following sections under the Access to Information and Protection Privacy Act (ATIPP Act):

• Section 75(a)(iv)	A position, plan, procedure or instruction, or estimates or criteria, developed for the purpose of contractual or other negotiations (including land claims and self-government negotiations, and labour relations negotiations) by or on behalf of the Government of Yukon or a public body, that, if disclosed, may harm the financial or economic interests of the Government of Yukon, or the ability of the Government of Yukon to manage the economy
