The Department of Economic Development has completed its review of ATIPP Request 22-204 after conducting a thorough search of the program areas for records responsive to this request and determined that the applicant's request will be granted in part related to the following request:

We would like to obtain financial data indicating any, and all funding that was released by the Yukon Government, and/or it's tourism, or economic development, or any other department, or subsidiary, in order to finance or provide funding support/grants/loans for the Young Presidents Organization (YPO) Alberta event which was hosted in May 2022. We would like to know how much money was provided by the aforementioned groups, who it was provided to, as well as any correspondence outlining what the funding was allowed to cover. We would also like to know how much money was paid to each organization that received funding from YG for this event, the planning, hosting, accommodations, and venue spaces that were rented. We also want to know how much was spent on transportation and what form of transportation this came in.

Timeframe: January 3, 2022 - May 21, 2022.

The response totals two (2) pages, the cheque requisition showing the entity funded and a summary of the terms of the transfer payment agreement.

Information pertaining to these pages have been partially severed in accordance with the ATIPP Act under the following sections:

Section 70(1)(3)(a)(iii) – Third party personal information. This record contains names of individuals and employment history of an individual.

Section 74(1)(a) – Policy advice or recommendations records contain advice or recommendations prepared by or for a public body or a minister.

Sections 75(1)(a)(ii)(iv) – Disclosure harmful to economic or financial interests of the public body. These records contain information that may prove harmful to contractual or third party economic or financial information of third parties and the government as a whole.

Sections 77(1)(a)(c) – Disclosure harmful to third party business interests. Records contain information regarding business dealings of third parties that may cause undue financial hardship or harm the competitive or negotiating position of a third party.

There is no cost to the applicant.
