Some of the records you requested contain information that has been withheld from disclosure under the ATIPP Act. We have severed the excepted information so that we could disclose to you the remaining information in the records. The records has been withheld pursuant the following sections under the Access to Information and Protection Privacy Act (ATIPP Act):

ATIPP Act Sections	Explanation
• Section 67(3)(a)	The head of a responsive public body must not grant an applicant access to a Cabinet record
• Section 74(1)(a)	Advice or recommendations prepared by or for a public body or a minister
• Section 76(1)	Disclosure could harm relations between the Government of Yukon and another government or organization
• Section 75(a)(ii)	Commercial, financial, scientific or technical information of the Government of Yukon or a public body and that has, or is reasonably likely to have, monetary value, that, if disclosed, may harm the financial or economic interests of the Government of Yukon, or the ability of the Government of Yukon to manage the economy
• Section 67(3)(b)	The head of a responsive public body must not grant an applicant access to information contained in a record other than a Cabinet record that, if disclosed, would reveal the substance of the deliberations of Cabinet.

There is no charge to the applicant.
