**Decision**

The Department of Health and Social Services has searched the Emergency, OH&S and Capital Maintenance Branch and has identified records responsive to Access Request 22-338. The final response on the information is as follows:

**Access Granted in Part**

The Department of Health and Social Services has granted access in part to the information relating to the request noted below:

*The applicant requires: all records (includes emails, text messages, digital messages, hand written notes, notes to file, memos, briefing notes, voicemails, voice memos, and any other communication systems used), related to: the nomination and/or appointment of Yukon Employees' Union (YEU) members to Joint Health and Safety Committees (JHSC), and, related to: the appointment and/or nomination to Yukon Employees' Union (YEU) members to any other health and safety committees.*

Timeframe: June 1, 2022 - July 15, 2022

Certain types of information have been redacted pursuant to the following sections of the Access to Information and Protection of Privacy Act:

- 70(1) – disclosure would be an unreasonable invasion of the third party's privacy
- 75(1)(a)(ii) – disclosure would reveal commercial, financial, scientific or technical information of a public body

*An applicant may, in respect of the head of a responsive public body's response to their access request under section 64, make a complaint to the commissioner by filing the complaint in accordance with section 90.*


