#### Decision

The Executive Council Office has searched the Premier's Office and the Deputy Minister's Office and has located records responsive to Access Request #22-451. Our final response on the information is as follows:

#### **Access Granted in Part**

NARROWED SCOPE #2: I've included a clean copy of the new further revised request below. As stated above, the only change in the language of the request is to the timeframe.

NARROWED SCOPE #3: Can you ask the public body if it would cut down document volume to only request documents authored by the Premier, instead of both documents authored by, or sent to, the Premier?

RESPONSE FROM DEPT #4: I specifically reached out to the Premier's office and they provided 4 pages and confirmed that everything would be filtered through the DM's office. I searched the records from the DM's office for "Sandy" there are about 17 pages from one of the Premier's Advisor's and some public Media Statements from the Premier.

Third party personal information consisting of a name and employment status has been redacted using section 70(1) of the ATIPP Act to protect personal privacy.

Advice or recommendations prepared by or for a public body or a minister have been redacted under section 74(1)(a) of the ATIPP Act.
