Decision

The Department of Environment has searched the Deputy Minister's Office, Policy, Planning and Implementation Branch and Conservation Officer Service Branch and has identified records responsive to Access Request #22-508. The final response on the information is as follows:

Access Granted in Part

The Department of Environment is granting access in part to information relating to the request noted below:

Requesting all records relating to moose and caribou quota decisions for outfitting concessions #15, #19 and #20. Please include emails between Department staff and outfitters or other stakeholders and any reports or justification documents for changes to quotas in these concessions. ADDITIONAL INFORMATION: Just to clarify, I would still like the responsive records from other branches. As regards Fish and Wildlife, please further limit to Liard Fish and Wildlife biologist, Wildlife harvest biologist, and Director Fish and Wildlife. ADDITIONAL INFORMATION: Can you please narrow further by removing Fish and Wildlife branch altogether. Please send responsive records from COSB, DM's Office and PPI.

Some of the records you requested contain information that has been withheld from disclosure under the ATIPP Act. We have severed the excepted information so that we could disclose to
