Final Response ATIPP Access Request 22-556

Decision

The Department of Justice has searched the Deputy Minister's Office, Policy and Communications and the Finance, Systems, Administration and Records branch and has located records responsive to Access Request #22-556. Our final response on the information is as follows:

Access Granted in Part

The Department of Justice has provided partial access to information relating to the request noted below:

I am looking for the most recent versions (up-to-date as of the final day of the Sitting) of departmental briefing notes prepared for ministers for the 2022 Fall Sitting of the Yukon Legislative Assembly as contained in any ministerial, issues, budget, and/or hot topic briefing binders. As well, I am requesting any individual departmental briefing notes on specific topics prepared for ministers in the 2022 Fall Sitting of the Yukon Legislative Assembly, but not contained within a binder. Timeframe: November 20, 2022 - November 25, 2022.

Information that would reveal the substance of the deliberations of Cabinet was withheld under section 67(3)(b) of the ATIPP Act.

Information that is subject to legal privilege of a public body or any other person has been redacted under section 73(a) of the ATIPP Act. Information that has been prepared for the Attorney General or public body in respect of the provision of legal services to or by the Attorney General has been withheld under section 73(b)(i) of the ATIPP Act.

Information reflecting advice and recommendations prepared for the public body or minister has been withheld under section 74(1)(a) of the ATIPP Act.

Information that is a trade secret of the Yukon Government has been withheld under 75(1)(b)(i) of the TIPP Act. Information that could reasonably be expected to harm the financial or economic interests of Government of Yukon has been withheld under section 75(1)(a)(ii) of the ATIPP Act.

Information was withheld under section 76(1) of the ATIPP Act as it could reasonably be expected to harm relations between the Government of Yukon or a public body and another government or organization.
