#### **Decision**

The Women and Gender Equity Directorate has identified records responsive to Access Request #22-561. Our final response on the information is as follows:

## **Access Granted in Part**

The Women and Gender Equity Directorate has provided access in part to information and records relating to the request noted below:

I am looking for the most recent versions (up-to-date as of the final day of the Sitting) of departmental briefing notes prepared for ministers for the 2022 Fall Sitting of the Yukon Legislative Assembly as contained in any ministerial, issues, budget, and/or hot topic briefing binders. As well, I am requesting any individual departmental briefing notes on specific topics prepared for ministers in the 2022 Fall Sitting of the Yukon Legislative Assembly, but not contained within a binder. Timeframe: November 20, 2022 - November 25, 2022.

### ADDITIONAL INFORMATION:

Question from Dept: The timeframe is stated to be November 20-25, but the second part of the request asks for "individual departmental briefing notes on specific topics prepared for ministers in the 2022 Fall Sitting of the Yukon Legislative Assembly, but not contained within a binder ". Some briefing notes that we prepared for our Minister during the sitting that were not included in the binder, may have been prepared before that timeframe and could be considered out of scope. Would you like to amend the timeframe or the wording of the request?

Response from App: Yes, as the time frame was intended to exclude earlier versions of notes and only those final notes as the binder existed in the final week. if we can amend the time frame to the start to finished of the sitting for briefing notes prepared for the minister that would be appropriate.

Information where disclosure could be harmful to intergovernmental relations has been withheld under section 76(1) of the ATIPP Act.
