Final Response ATIPP Access Request 22-710

Decision

The Department of Environment has searched the Environmental Protection and Assessment and Conservation Officer Services branches and has identified records responsive to Access Request 22-710. The final response on the information is as follows:

Access Granted in Part

The Department of Environment has granted access in part to information relating to the request noted below:

Location: Shell former Peel River YT J-21 Exploratory Wellsite and Staging Area (including former waste disposal site), on Gwich'in Private Lands in the Tetlit Gwich'in Secondary Use Area Coordinates: J-21 Wellsite -66*30' 31.9" N,134* 4' 32.3" W (well drilling application) - 66* 30' 31.9" N, 134* 4' 23.3" W (well abandonment application) J-21 Staging Area - 66* 30' 7.60" N, 134* 4'24.95" W All coordinates are for activities associated with the J-21 Wellsite, some work happened in different areas depending on the activity. Records: Environmental records, information pertaining to spills or complaints, enforcements, delineation reports, status of the sites, incident reports, reports by other consultants with respect to soil and groundwater contamination. Timeframe: January 1, 1960 – February 28, 2023.
