The Department of Health and Social Services has searched Population and Public Health Evidence and Evaluation and Community Health Programs and have identified records responsive to Access Request 23-166:

Original Request: I would like to request the following data points stratified by date, age group and sex for the time period 2015-most recent (if possible). We would like to receive the data in an excel spreadsheet (or CSV file). The data will be used for data analytics models trying to forecast the burden of disease. Number of patients hospitalised with Influenza, and in a separate column Respiratory Syncytial Virus (date [month], age group, sex) Number of patients occupying Intensive Care Units with Influenza, and in a separate column Respiratory Syncytial Virus (date [month], age group, sex) Total number of deaths in the country due to infection with Influenza, and in a separate column Respiratory Syncytial Virus (date [month], age group, and sex) For Flu the ICD10 code is J10 and for Respiratory Syncytial Virus the ICD10 codes are J21.0, J20.5, and J12.1

Additional Information: For the age groups the following grouping would be great: <1; <5; 5-14; 15-29; 30-44; 45-59; 60-89; 90+ but if that's not possible feel free to suggest other groups, and we would like to know hospitalisation/ICU/death due to infection with influenza, please.

Timeframe: January 1, 2015 - July 17, 2023


