## **Decision**

Certain types of information have been redacted pursuant to the Access to Information and Protection of Privacy Act. A summary of these redactions is enclosed.

The original estimate of costs for this request was based on an estimate of the number of records that would be received. The actual records received was less than estimated and has been indicated in the summary of redactions as attached. In addition, duplicate documents and out of scope documents have been removed. Also of note, pages 235 to 437 in the final

response package have not been included in the fee calculation as this is a publicly available document and there is no charge associated with it.
