# Final Response ATIPP Access Request 23-607

The Department of Justice has searched Public Safety and Investigations branch and has identified records responsive to Access Request 23-607 noted below:

Records mentioning the rumoured or confirmed consumption, selling and/or buying of illicit drugs at the Whitehorse Emergency Shelter, the Supervised Housing and Reintegration Program and any other properties and programs operated by Connective in Whitehorse.

Timeframe: October 1, 2022 - February 20, 2024

the relevant program area would be Community Justice and Public Safety, and specifically the community corrections and public safety and investigations divisions. looking for records related to any unsanctioned illicit drug consumption, drug selling or drug buying taking place in or around Connective properties.
