Decision

Yukon Hospital Corporation (YHC) has searched the Pharmacy Department and identified records responsive to Access Request 23-613. The final response on the information is as follows:

Access Granted in Part

Yukon Hospital Corporation has granted access in part to information relating to the request noted below:

I would like to know the number of dispensations for each of four different drugs from all of HSS –Suboxone, naltrexone, methadone and buprenorphine – for the years 2015 through Dec. 31 2023, by month. If Justice dispenses any of these drugs through the Corrections system, please include. Also if any are dispensed through the Yukon Hospital Corporation. Timeframe: January 1, 2015 - December 31, 2023.

ADDITIONAL INFORMATION:

There is one document included in this package.

There is no information available between 2015 and June 2021, as the Hospital switched over to Meditech Expanse. All information from the previous Magic environment has been purged. All information from June 2021 to December 2023 is included.
