Final Response ATIPP Access Request 23-680

Decision

Yukon Hospital Corporation (YHC) has searched the Finance and People Services and Culture Departments and identified records responsive to Access Request 23-680. The final response on the information is as follows:

Access Granted in Part

Yukon Hospital Corporation has granted access in part to information relating to the request noted below:

The Yukon Hospital Corporation (YHC) operates a Deferred Salary Leave Plan (DSLP). Section 5 of that plan states: "Accrued interest income from the trust fund, minus costs incurred in the administration of the fund, will be paid out to participants of the DSLP, on an annual basis in the year in which it is earned. The full amount of interest income is taxable in the year it is earned, as income from employment, and appropriate income tax information slips will be issued as required." I would like to know: - How many employees utilized the plan during this period, and what were their gross contributions - What was the gross and net accrued interest in the period - When/how was this interest disbursed to participants - What were the "cost incurred in the administration of the fund", itemized - Upon what tax form, and box therewith-in, were these earnings reported - Using what instruments is the funds money invested - Has the fund been independently audited in this period. Timeframe: February 1, 2024 -March 26, 2024
