The Department of Highways and Public Works has searched Procurement and Transportation Maintenance and has identified records responsive to Access Request 24-756 noted below:

We are requesting for the technical submission of 843842 Yukon for Whitehorse/Carmacks and Teslin and Haines Junction rest stop cleaning tender. We are trying to understand how their submission for Teslin and Haines Junction was opened but was not opened for Whitehorse and Carmacks when no results were released prior to the closing of all the rest stops. Timeframe: February 1, 2025 - March 26, 2025.
