Decision

Yukon Hospital Corporation (YHC) has searched the Medical Services and Finance departments. YHC has identified records responsive to Access Request 25-091. The final response on the information is as follows:

Access Granted in Part

Yukon Hospital Corporation has granted access in part to information relating to the request noted below:

I am the [withheld]. In this role, I am looking into inequities in ''bonus'' payments made by YHC to certain physicians in the months of April and May 2025. These are specific payments that will be in multiples of \$1000 since I understand they were offered at a rate of \$1000/day. Payments may mention the ''hospitalist'' program. I don't need physician names, just dates and dollar amounts, and ideally the date range/services covered by each payment (ie something like ''\$4000 for 4 days from April 2-5 at \$1000/day''). Please let me know if this is possible and if there's anything else you need from me.

Timeframe: April 1, 2025 - May 16, 2025
